
Mission

NEW RATTITUDE, Inc., a non-profit charitable corporation incorporated in 2008, is a 100% volunteer-operated, nationwide group dedicated to the rescue and adoption of abused, abandoned, neglected, sick, or unwanted Rat Terriers and Rat Terrier mixes.

In private foster homes, the dogs are nurtured, socialized, trained, supported medically, and provided with professional veterinary care while we work diligently to find them new, permanent adoptive homes where they will be safe, loved, and properly and humanely cared for the rest of their lives.

Each dog brought into our network receives a veterinary check, all required vaccinations, heartworm test and monthly preventative, and spay or neuter. Other medical care is sometimes necessary, such as treatment for heartworm disease, infection, allergies, broken bones, or surgery to correct a variety of ailments. Each dog is dewormed, microchipped, and given a martingale collar, along with a collar tag printed with a unique ID number and our toll-free Lost Dog Hotline.

New Rattitude is licensed by the Georgia Department of Agriculture, registered with the Georgia Secretary

2024 Accomplishments

Our labor of love begins and ends with the heart and soul of New Rattitude—our volunteers. New Rattitude is a national organization, completely run by volunteers. Our network of foster homes is supported by a "staff" of other members who manage a variety of necessary tasks, including administration, application screening, fundraising, transportation coordination, publicity, technology, and so on.

Outside of New Rattitude's membership, we have another amazing support network of volunteers who help us drive dogs from shelters to foster homes, between foster homes, or from foster homes to adoptive homes, or assist with home visits to ensure our foster Rat Terriers are placed in safe and suitable environments.

We are also grateful for those who support New Rattitude by contributing generously, participating in our fundraisers, and by spreading the word to let other dog lovers around the country know about New Rattitude and our efforts!

Our volunteers are not paid, but they are priceless. We couldn't carry out our mission without them.

So, what did we collectively accomplish in 2024 through this network of dedicated volunteers and supporters?

- Eighty-six (86) Rat Terriers were rescued.
- Eighty-five (85) Rat Terriers were placed into loving adoptive homes.
- Cumulative rescues and adoptions since New Rattitude's 2008 incorporation total 2,785 and 2,843 respectively!
- Eight new volunteers were approved for membership, including four new foster parents.
- Adoption applications processed totaled 377 —an average of 31 per month.
- New Rattitude's Transport Team coordinated 40 transports, carrying 48 dogs. Twenty-three were ground transports carrying 31 dogs; 17 were air transports carrying 17 dogs and involving 21 aircrafts.
- Our partnership with <u>Pilots N Paws</u>® that allows our rescued Rat Terriers to fly to foster home spots all over the country is a game changer! Pilots N Paws is a 501(c)(3) non-profit organization that connects rescues with volunteer pilots and plane owners willing to assist with animal transportation. Pilots donate their time, use of their planes, and their fuel to transport animals to places where they will be fostered and/or adopted. We are so grateful for their help!
- We paid for 125 vaccinations, 57 heartworm tests, 58 spays and neuters, 19 other surgical procedures, 15 dental cleanings and extractions, three heartworm treatments, and numerous x-rays, blood panels, and other diagnostic and laboratory tests.
- We sponsored the 19th annual Rat Terrier Jamboree in Sweetwater, TN in late April.

These achievements and more were made possible by all of you! Thank you for believing in our mission and for trusting in New Rattitude to carry it out.

They learned to trust; their self-confidence grew; and when they were healed and ready, carefully selected homes were found where these precious reclaimed souls would be cherished "furever."

New Rattitude's 2024 Canine Clinic Dogs

Some of the dogs rescued by New Rattitude have severe illnesses or other serious medical issues that are much more costly than the money brought in by adoption fees. To help nurse these dogs through their medical needs so that they can eventually be healthy and adoptable, we find sponsors to help with the costs. In 2024, sponsors helped with the supplemental vetting costs for these dogs in New Rattitude's Canine Clinic.



Rosie was adopted in May 2024 and resides in Virginia.



Biscuit was adopted in July 2024 and resides in Virginia.



Sweetie is still on medical hold, but we hope she will be available for adoption sometime in 2025; her foster home is in Moncks Corner, South Carolina.

Rosie- Injured Tail

Rosie was left outside a vet's office with half her tail missing. New Rattitude responded to their call for rescue help.

Rosie needed surgery to repair her tail, but stayed energetic and happy despite everything. New Rattitude received enough donations from supporters to cover her \$669 surgery and Rosie wagged her once-injured/now-repaired tail to show her thanks!

Biscuit -Heartworm Disease

Three New Rattitude foster dogs had to undergo heartworm treatment in 2024. "Heartworm positive," means a dog has been bitten by a moquito carrying the disease from another infected dog. Left untreated, the result is irreversible heart and lung disease, preceded by shortness of breath, cough, and fluid build-up.

Treating heartworm infection is very expensive (about seven times the cost of annual heartworm preventative!) and requires months of treatment and multiple veterinary visits. Thank you to all the donors that sponsored Biscuit's life-saving treatment. You are our heartworm heroes!

Sweetie - Blocked Salivary Gland

Our "Sweetie" can't catch a break. Last winter she was left in a vacated home where she was without food and water for an unknown length of time. New Rattitude was contacted and swooped in for the rescue. Sweetie had mastitis and high liver enzymes and is heartworm positive. Her time in foster care has been a constant series of vet visits, procedures, and tests. Her most recent ailment required surgery to remove a damaged salivary gland.

After spending nearly \$5,000 to diagnose and treat Sweetie's various ailments, this \$4,000 surgery was a big hit to our rescue budget. Once again, our supporters came through with financial help and Sweetie has made a nice recovery from her surgery.



Pepper - Broken Leg

This poor little Rat Terrier mix girl was picked up as a stray in Charlotte, North Carolina with a broken leg. She was fortunate to be rescued by New Rattitude and transferred to a Florida foster home where she had successful surgery to repair the fracture. The procedure included some plates and screws to

help the bones heal and keep them in place. After the surgery, Pepper had six weeks of healing with no running, jumping, or playing. Finally, she got the "all clear" to return to normal activities and fun! Thank you, supporters, for making this new life possible for sweet Pepper!

Pepper was adopted in January 2025 and resides in Florida.



Ziggy - Broken Pelvis and Femur

After being struck by a car and spending a month in a North Carolina county shelter with a broken pelvis and femur, one-yearold Ziggy was rescued by New Rattitude and given the needed surgery. The cost of his surgery was nearly \$5,700; with follow-up care the cost was \$6,400.

We received loving donations for Ziggy from all over the country. He had no clue how many people supported him and cheered him on to wellness! See the related feature story on pages <u>18-19</u> for full details of Ziggy's amazing rescue story, including an update on how he's doing today!

Marla - Shattered Pelvis, Broken Femur

2024 was the year of car accident injuries. Like Ziggy, one-yearold Marla was hit by a car and suffered a broken left femur and a shattered pelvis. Another similarity to their stories was that she was taken to a county shelter that didn't have the budget for expensive medical treatment. She would have been euthanized within hours if New Rattitude hadn't stepped in to save her.

Unlike Ziggy, due to the severity of Marla's injuries, her leg couldn't be saved. Despite having her left rear leg amputated, Marla healed well from her surgery and now runs as fast as the wind on her three legs! More good news - she was adopted to a quiet, loving home with two other gently playful dogs (also adopted from New Rattitude).

Marla was adopted in November 2024 and resides in Virginia.





Over 80% of New Rattitude's expenses go toward medical care for our foster dogs. Adding in the cost of dog food, dog transportation, boarding, microchips, ID tags, and collars, 87% of our spending is directly related to the rescue and care of needy Rat Terriers.

"TAILS" OF TWO RESCUES The rescues of Ziggy and Pixie

Dog rescue isn't always easy. It takes passion, compassion, energy, ingenuity, creativity, flexibility, and hard work. Fortunately, New Rattitude has been blessed with volunteers who possess these qualities and a "do-what-it-takes" mentality to save Rat Terriers in need. This year's annual report feature story is about two particular rescues – one at the beginning of 2024 and the other at the end.

ZIGGY'S RESCUE

There's just something special about dogs named Ziggy! Is it their courage? Resilience? New Rattitude's handsome Ziggy, a rattie mix, had plenty of both. This is his rescue story.

HOW IT STARTED

December 12, 2023: One-year-old Ziggy was hit by a car and suffered a broken pelvis and femur. He was taken to a county shelter in Fayetteville, North Carolina that didn't have the budget for expensive medical treatment.

WHAT HAPPENED NEXT

January 5, 2024. The shelter reached out to New Rattitude for help. We couldn't stand to see this sweet boy hopeless and in pain, so enthusiastically agreed to bring Ziggy into our foster care program.

January 5-10, 2024: Planning began immediately. Getting Ziggy to a vet for surgery was top priority because nearly a month had already passed since the car accident. The shelter contacted local surgery clinics but none were available or able to perform surgery. We knew we had to move Ziggy to a specialty clinic outside of Fayetteville. An experienced and trusted veterinary surgeon in Winterville, Georgia was consulted. He reviewed radiographs from the shelter but was skeptical about getting good results if surgery had to be delayed until a 300-mile transport could be arranged. The longer the wait, the more difficult the surgery and the greater the likelihood of irreversible nerve damage would be. He recommended referral to a closer surgeon who could perform surgery quickly. Volunteers began calling Raleigh, NC specialty vets (just an hour from Fayetteville). After multiple phone calls, we finally located a clinic in Cary, NC (just west of Raleigh) that could medically board Ziggy until he could fit into their surgical schedule.

January 11, 2024: Mike and Phyllis, the parents of New Rattitude volunteer Molly Miller, picked up Ziggy from the shelter and drove him to Quartet Veterinary Specialty Hospital in Cary. Ziggy's crate was well padded with a pillow, towels, and blankets to keep him comfortable and minimize movement.

January 16, 2024: Ziggy had surgery to repair his broken pelvis and femur. As usual, New Rattitude's supporters were responsive and generous, sending in lots of donations and well wishes to help out with his \$5,700 surgical bill. We received loving donations from all over the country: California, Washington State, Louisiana, Georgia, Illinois, Michigan, Washington DC, Maryland, Massachusetts, New York, and Florida!

January 17-18, 2024: Jenn S., a friend of Molly Miller's, picked Ziggy up at the clinic the day after surgery, kept him overnight, and drove him to the airport the following day. Pilot Conor with Pilots N Paws then flew our little Ziggy from Cary to his foster home in Laurel, Maryland via private plane.

January 27, 2024: Ziggy had his stitches removed. Soon after, he began using his newly repaired leg. There was some nerve damage so his foster mom, Lisa Rohn, did range of motion exercises with him and took him on short walks. By early March, he was strong enough to walk a few miles a day.

March 13, 2024. Ziggy had neuter surgery.

April 5, 2024: Ziggy had a consultation with a neurologist because he was still "knuckling" his rear paw. X-rays showed his hip was still healing, but some nerve damage remained. The neurologist reassured Ziggy's foster mom that further healing of the nerve could occur slowly.

Finally, Ziggy was ready for adoption! Although he still sometimes ran on three legs, he did zoomies and navigated stairs, with energy left to play with the bigger dogs in his foster home! Nothing seemed to stop this resilient little boy, who was so ready for his forever home.

HOW IT ENDED

June 23, 2024: **Ziggy got adopted!** It took some time to get that perfect adoption application, but finally it came from previous New Rattitude adopters who had two Rat Terriers to be Ziggy's playmates. Ziggy settled right in to the Crider household and quickly became one of the pack. Our hearts were full!

As you can tell, this rescue took a village of New Rattitude volunteers, plus a few friends and family members as well. New Rattitude volunteers do this work selflessly day in and day out but deserve special recognition for Ziggy's rescue. It wouldn't have possible without **Lisa Rohn** agreeing to be Ziggy's foster mom, **Molly Miller** coordinating his shelter pull, **Karen**

Stewart finding a vet that could do the surgery, **Mindy Shapiro** coordinating vet care, and **Pat Graham** coordinating transport.

Little Ziggy had no clue how many people helped and supported him and cheered him on to wellness, but we're sure he felt the love.

PIXIE'S RESCUE

HOW IT STARTED

Rat Terrier rescue does not shut down for the holidays. On December 20, New Rattitude was notified about a one-year-old, five-pound female Rat Terrier mix in a southern California animal shelter who was desperately in need of rescue. She had a possible spinal injury, so the shelter did not consider her a candidate for public adoption.

WHAT HAPPENED NEXT

New Rattitude volunteer **Denise Gilroy** contacted the shelter to get more information. She recruited **Hailey Cole**, a volunteer in southern California, to spring Pixie from the shelter and keep her until transport to another New Rattitude foster parent could be arranged. She also recruited **Nicole Dossey** in Pullman, Washington, to accept Pixie as a foster dog.

Hailey pulled Pixie from the shelter and gave her safe refuge in her home while Denise began researching transport options, eventually securing a flight through Delta Animal Rescue Transport (DART), a group of Delta airline employees who volunteer to transport rescued cats and dogs in their free time. Hailey took Pixie to the vet for a health certificate to clear her for flying.

Plan A was to fly Pixie from Los Angeles, California to Spokane, Washington on New Year's Eve. The Delta employee transporter (Stephanie) and Pixie were on standby, so we nervously waited to see if they'd get a seat. Unfortunately, the flight filled up. So we went to Plan B, which was for Stephanie and Pixie to fly from Los Angeles to Salt Lake City, Utah on New Year's Eve and then take a New Year's Day morning flight from Salt Lake City to Spokane.

Hailey took Pixie to the busy airport, where she had to wait for many hours until boarding (in case anything fell through), and Pixie went on to spend New Year's Eve in Salt Lake City with Stephanie and her husband and two daughters who were Stephanie's helpers with Pixie's transport. On New Year's Day, Stephanie, her daughters, and Pixie were able to board the flight to Spokane.

Meanwhile, Nicole departed Pullman to meet Pixie and her transporters at the Spokane airport, a drive of about 75 miles on snowy, treacherous roads. After landing, Stephanie located Nicole and delivered Pixie to the arms of her caring foster mom. Stephanie and daughters returned to Salt Lake City, while Nicole and Pixie headed back to Pullman.

HOW IT ENDED

This is the end of Pixie's rescue story, but only the beginning for Pixie. New Rattitude will make sure her medical needs are treated, then we'll start the search for her ideal forever home.

Rescue isn't easy, but it makes all the difference to the dog.

POST SCRIPT

Ziggy's and Pixie's stories are just two of many rescue stories we could tell for 2024. Some are less complicated and require fewer volunteers to pull off, but each one of them is unique and challenging in some way. New Rattitude receives rescue requests from shelters and individuals on a regular basis, and we're often tagged on social media posts. We wish we could save every Rat Terrier in need, but we are limited by the number and location of foster homes to take them in. We can *always* use more foster homes. Please consider joining New Rattitude as a foster parent in 2025 – you can foster for New Rattitude from almost anywhere in the USA. With more foster parents, like **YOU**, we can respond to more pleas for rescue help.

In Loving Memory Susan Almond Beard 1953 - 2025



With immense love and gRATitude, the New Rattitude community remembers Susan Beard, one of our organization's original founders. Susan served on the New Rattitude Board of Directors since 2009 — as Vice President in 2010 and 2014, as President in 2011 and 2012, and as Secretary from 2016 through 2024. She also directed our ReHome Program since 2009, finding homes for almost 100 Rat Terriers who didn't fit into our foster care network. Susan was an extremely talented graphic designer and publisher, the driving creative force behind our various annual initiatives (the Photo Contest, calendar, holiday fund drive, Annual Report, and yearly T-shirt design) as well as various other New Rattitude publications, such as publicity rack cards, flyers, and a long-running monthly newsletter. Essentially, when New Rattitude needed something done right, we counted on Susan.

New Rattitude wasn't Susan's first association with a Rat Terrier organization. In 2006 she was one of the original founders of the Southeast Rat Terrier Jamboree. Along with a small group of rattie-loving cohorts, including our own Debbie & Rick Collins and Patti & Jim Jeffries, these dedicated individuals took over a previous Rat Terrier "convention" and turned it into a fun annual event in Sweetwater. TN. where ratties and their humans from all over the country come together to play, engage in friendly competition, hang out, meet new friends, and network. After several years, as Jamboree grew bigger and bigger and as the leaders became more and more closely affiliated with New Rattitude, they decided in 2012 to bequeath Jamboree to the New Rattitude organization. And thus was born the New Rattitude Rat Terrier Jamboree with an expanded crew of organizers and workers. Anyone who has been to the Jamboree has met Susan — faithfully handling all of the registrations and advance materials, manning the registration booth, enrolling the contest participants, and just generally keeping things running smoothly.



Besides being a Rat Terrier rescuer and enthusiast, this strong, smart, and independent woman was, through the years, a musician, medical lab tech, teacher, carpenter, fisherman, antiques dealer, graphic designer, business starter, and the most wonderful mother.

Susan, we thank you for your service and friendship. You are FUREVER in the heart of New Rattitude.
